3rd VP OF FUNDRAISING – Dorothy Dentry

As the 2018-2019 year comes to a close, we look back at a recap of SARW Fundraising events. The Fine China Luncheon March 28 sold 210 tickets with income of \$6,300 and silent auction sales of \$2,300 for a total income of \$8,620 (includes a \$20 donation.) The Club netted \$4,669.62. We had 18 individuals and 7 businesses decorate tables.

The Poinsettia Sales began on September 1, 2018 and by November 30, SARW had sold 330 poinsettias to individuals and businesses. The Club realized a profit of \$1,462. The proceeds from this project benefited our Salado High School Scholarship and supplies for our military project. We are most appreciative to all who attended and/or participated in these two great events.

LEGISLATIVE UPDATE – Jessica Menking Diem

Memorial Day brought the end of the 86th Legislative Session! We saw great success in terms of property tax relief and reform and school finance reform, which was a priority set out by Governor Abbott, Lieutenant Governor Patrick, and Speaker Bonnen early in January.

HB 1, the state's budget, finished as a balanced budget, stayed under the rate of population plus inflation, and stays under all four constitutional spending limits.

SB 2, the Texas Taxpayer Transparency Act, will provide for real-time tax information, to include who is proposing rate increases, and protest information. SB2 also lowers the approval rate to 3.5% and triggers an automatic election should the increase exceed that amount.

HB 3, The Texas Plan, is transformational school finance reform. It provides almost \$5 billion in property tax relief by increasing the state's share of education funding to buy down school district property taxes. Along the reform vein, it also mandates ongoing reductions in school property tax rates and requires districts to conduct efficiency audits to ensure that taxpayer dollars are being used responsibly.

The Texas Plan, in its educational credits, adds \$4.5 billion in reforms to benefit students, personnel, and districts, adds \$2 billion in pay raises for teachers, counselors, nurses, and librarians, and reduces recapture statewide by \$3.6 billion.

Among other credits to the 86th Legislative session, we saw SB 500 make great leaps in funding the Teacher Retirement System and pension, and we saw much needed reforms in higher education that will protect students' freedom of speech and expression, streamline credit transfers, and protect students from hazing and sexual assault. Emergency preparedness was an important topic as well, continuing to fund the rebuilding of Texas towns and cities after Hurricane Harvey and making plans to be better prepared for the future. Great strides were made in support for veterans and military spouses, healthcare and mental healthcare, protecting and advancing our 2nd amendment rights, and promoting individual liberty.

The end of the session also brought great accolades for Salado's own State Representative Brad Buckley, who was honored as the Texas House Republican Caucus's "Freshman of the Year" for his character, leadership in the party, commitment to conservative principles, and his passionate representation of his constituents. Congrats Rep. Buckley!
