FROM THE DESK OF STATE REPRESENTATIVE BRAD BUCKLEY

The month of April was productive and significant in the Texas House. Chief among these was passing a fiscally responsible and conservative budget, balanced and within Constitutional limits. We saw important Republican priorities passed on the House floor: Broadband expansion across Texas (HB 5- Ashby et al, SB 632- Buckingham/HB 1715- Buckley), the Freedom to Worship Act, protecting religious liberties (HB 1239- Sanford), Constitutional Carry (HB 1927), Winter Storm reforms (HB 14- Goldman), and meaningful legislation for first responders relating to COVID-19 compensation (HB 541- Patterson). In committee, we saw hearings for critical pro-life measures: the Heartbeat Bill (HB 1515- Slawson) and the Pro-Life omnibus bill (HB 3760- Oliverson), as well as hearings on election reform and integrity (HB 6- Cain).

Of numerous bills that I authored, I was proud to see passage of HB 3067, a designation for Highway 195 in Bell and Williamson Counties as part of the National Purple Heart Trail to honor brave service members who have sacrificed for our nation, as well as a hearing on HB 125, which would amend the Disabled Veterans Homestead Exemption Reimbursement Program to include additional disproportionately impacted communities in HD54.

Our district office remains as busy as ever, assisting constituents with access to state agencies regarding unemployment, driver's license issues, veteran employment through Texas Veterans Commission, Child Protective Services, child support services, and environmental concerns with Texas Commission on Environmental Quality (TCEQ), to name just a few.

FROM THE DESK OF STATE REPRESENTATIVE HUGH SHINE

The legislative session is now in full swing. We are meeting daily with sessions extending into the evening. As in previous sessions, I have focused on the state property tax system, to give property taxpayers as many tools in the toolbox as possible as they protest their appraisals each year. As a member of the House Ways and Means Committee my goal is to continue to review the system and its processes, provide remedies to taxpayers who protest their appraisals when appraisal district procedures are ignored or abused and look for improvements to the system that may be a benefit to property taxpayers. The Appraisal District Board is responsible for the budget and supervises the chief appraiser who has the responsibility of appraisal operations. The Appraisal Review Board is instrumental in hearing appraisal protests of real and commercial properties that are not settled by informal appraisal reviews. Counties, cities, schools, and special districts are dependent on the process that we as taxpayers fund through the taxes assessed on the value of properties we own. This is an especially important area of responsibility to our state. I have created a working group of professionals from across the State of Texas that includes representation from the Governor's office, the Comptroller, Tax Assessor-Collectors, Chief Appraisers, municipalities (Counties, Cities, Schools, Special Districts) and individual and commercial property tax consultants who have been meeting weekly/monthly throughout the past four years to further improve the property tax system we pay for that supports local Texas governments. I encourage you to sign into the website (TLO) and review the property tax initiatives I have authored.

This session we have many issues that affect our lives and the growth of our state as a result of COVID 19 and Winter Storm Uric issues, initially slowing down our legislative agenda. Over the past two weeks the legislative OPTEMPO has accelerated as we enter into the final 30+ days of the session. Passing the state budget, funding public schools, strengthening the security of our elections, extending internet service across Texas, providing for continued economic development, and protecting life are just a few of many important issues we are authoring, joint authoring or co-authoring.

The 140-day Session ends May 31. We have a lot of work that will be stuffed into these final weeks and days, including constitutional carry, pro-life issues, election reforms, power grid issues, Medicaid, education and too many to mention in a short blurb. LEGISLATIVE UPDATE – Brenda Keller

Proposed Bills that we are following and their status:

- HB329 (Cain) – Relating to Election Integrity. - Still in Committee
- HB335 (Cain)- Relating to the cancellation of a person’s voter registration on notice that the person has acknowledged that the person is not a citizen, providing a civil penalty, creating a criminal offense. -
- HB574 (Bonnen) – Relating to the prevention of fraud in the conduct of an election. – House: Out of Committee / Senate: In Committee
- HB1368 (Leach)- Relating to election fraud; increasing a penalty. – Still in Committee
- SB155 (Perry)- Relating to the use of information from the lists of noncitizens and nonresidents excused or disqualified from jury service. - Senate: Out of Committee and referred to the State Affairs Committee / House: In Committee
- HB2339 (Klick)- Relating to the use of information from the lists of noncitizens and nonresidents excused or disqualified from jury service. - Still in Committee
- HB2546 (Jetton)- Relating to the enforcement by the secretary of state of certain voter roll maintenance provisions; creating a criminal offense. – Out of Committee sent to Calendars
- SB7 (Hughes)- Relating to elections, including election integrity and security; creating a criminal offense; providing civil penalties. – House: In Committee / Senate: Out of Committee
- HB6 regarding Election Integrity has passed out of the House Elections Committee and needs to go to the floor for a vote.
- SB10 regarding banning Taxpayer Funded Lobbying- Senate: Out of Committee / House: In Committee.

Constitutional Carry passed in the House and is now in the hands of the Senate. Gender Modification passed out of the State Affairs in the Senate and Public Health in the House. Abolition of Abortion bills passed out of the House Public Health Committee and has gone to the floor for a vote. Monuments had a bill passed out of a House Committee and needs a floor vote.

It appears that on some committees are stalling on some of these bills. We need to pressure our elected officials to keep bills moving.

Caring for Those Who Protect Us

The Border Care Project was begun in 2019 from a simple request for Hand Sanitizer from a Border Agent to a caring young Republican Woman in the Rio Grande Valley.

The program continues with the need hugely increasing with COVID and the enormous number of caravans arriving. Several officers have already died of COVID from direct contact with illegals. SARW has joined this effort this spring with our sister club in the Valley. We have seen the greater need due to the ever-increasing number of illegals the agents must process. The hygiene items that the agents need:

Hand Sanitizer, Towelettes, Wound Wash, Bug Spray, Sunscreen

To avoid shipping and handling SARW is collecting funds to purchase hand sanitizer online so the items may be shipped directly to the Republican Women's Club who are distributing the items.

At the April 22nd meeting we collected \$185 in cash and have ordered requested supplies for this project. The need will continue until the border problems are fixed.
